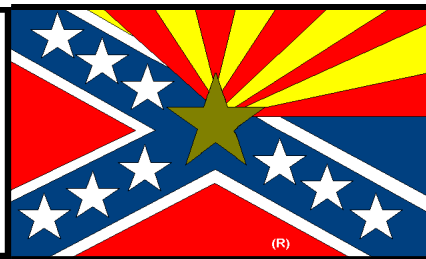

It is a battle cry! It is our focus for this time of year! Membership renewal is upon us!

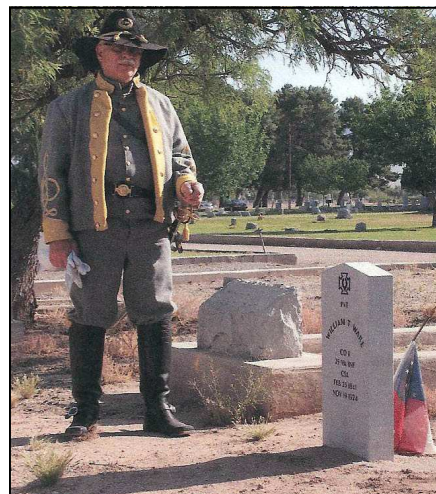
At the 114th Annual SCV Reunion in Hot Springs, Arkansas, last month, the Arizona delegation was introduced to Compatriot Jeff O'Cain from the Lt. Gen. Wade Hampton Camp #273, Columbia, South Carolina. Jeff has been working on the Membership Renewal System for *seven years*! Finally, this year thanks to Jeff, we have 13 Divisions, including Arizona, participating. Nearly 23,000 of our current members and 7,000 delin-

quents have, or will have received an MRS this year!

This system will close the "backdoor" through which too many members go by not getting a statement for renewal. Compatriot O'Cain conducted surveys that reveal this to be a major cause of lost membership: "...Well, nobody told me dues were due!" This was the most common response he had from delinquent members.

Once Compatriot O'Cain explained the program to myself, and others in the Arizona delegation, we were on board! This system will make our membership more secure, more predictable than before. It ensures that each member of a Division receives at least one formal notice of membership renewal annually. It assists the adju-

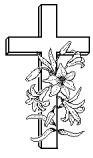

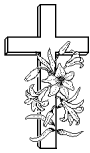

tants by issuing a professionally produced renewal statement on their behalf to all camp members. Also, one of the strong points of the system is that it allows solicitation for donations as Optional Giving for selected Division-approved projects, funds, and projects. Compatriot O'Cain expects to raise between \$100,000 and \$150,000 in Optional Giving heretofore not realized simply because the membership was not asked! It also will improve reinstatement of former and delinquent members, and improve and update personal data.

All of this is done in a professional, businesslike manner on par with other organizations like VFW, DAV, NRA, etc.

You may want to read the article by Adjutant-in-Chief Mark Simpson in the July-August *Confederate Veteran* on page 58. It should answer most questions, if not, contact our Adjutant, Curt Tipton.

The cost for the professionally laser printed MRS to the Arizona Division? About \$110 dollars! The printing job was subsidized by GHQ, and also, our run was "piggy backed" on larger Divisions' runs which greatly cut our overhead costs as well. So, if we retrieve just a few of our lapsed members, it will pay itself off.

We have now a golden opportunity to gain back our delinquent members, and per-

haps this will garner new members as well. Realizing this, I have tasked all Camp Commanders to conduct a 100% contact program with their members, active and delinquent. Your Commander will be giving you a call during the month of September, unless he sees you in person. When he calls, be sure to thank him for all the work he does to keep the Camp running!

In a related thought about membership, it should be noted that, statistically, there are, conservatively speaking, about one million men in Arizona who have Confederate heritage, and how do we reach them? That's a whole other can of worms we'll wrestle with another time!

We are getting close to the sesquicentennial of the Cause for Southern Independence, and we want to be strong in membership, and financially, so that we can honorably carry out our Charge to our forefathers.

So, let's get going on membership renewal, and bring our Division up! We can do it and we can lead the Army of the Trans Mississippi as the Division that grew the most in 2009 and 2010!

Many of our Compatriots and their family members are eligible for this award. For information about applying for the award for a Camp member, a family member, an Associate member or yourself, contact your Camp Adjutant or the Division Adjutant.

One is eligible if that person served honorably in the armed forces of these United States during the following periods:

WWII: 7 Dec 1941-31 Dec 1946
Korea: 25 Jun 1950-31 Jan 1955
Vietnam: 28 Feb 1961-7 May 1975

Lebanon-Grenada: 24 Aug 1982-31 Jul 1984

Panama: 20 Dec 1989-31 Jan 1990

Gulf War (including campaigns in Afghanistan & Iraq): 2 Aug 1990 -to cessation of hostilities.

The application may be downloaded from www.scv.org. It should be submitted to your Camp Adjutant or the Division Adjutant with a copy of your DD Form 214 or similar document.

15th Annual Arizona Division Reunion & Convention

Tucson, A.T. 6 June 2009

The Captain Hunter's Arizona Rangers Camp 1202 hosted the 15th Annual Arizona Division Reunion & Convention this day at the Olde Pueblo Grille in Tucson.

Six of the nine Camps were represented, meeting the requirement for a quorum.

Guests included Ms. Janet Grams, Past Treasurer-General of the United Daughters of the Confederacy; Mrs. Norma Laitem, President of the Arizona Division UDC; Mrs. Ella Mears, Past President of the Arizona Division UDC; Mrs. Paulette Lollar, President of the Thunderbird Chapter 2102, UDC; Mrs. Gretchen Brittain, President of the John R. Baylor Chapter 2298, UDC and Mrs. Emilie Siarkewics of Chapter 2298.

Division Commander Rich Montgomery opened the business session with Honors to the Colors. Chaplain Steve Ledbetter of Camp 1202 gave the invocation and Division Adjutant Curt Tipton read the Charge.

The Past Division Commanders in attendance presented the Division Commander's badge of office and commission to Commander Montgomery. As the reader will recall, Commander Montgomery assumed the office of Division Commander last Feb-

ruary upon the deployment of Division Commander David Barton to Kuwait.

The Adjutant read the minutes of the last convention. The delegates voted to approve the minutes as read.

The Adjutant gave the financial report, which was approved and sent for audit.

The Division received correspondence from the Arizona Secretary of State's office requesting that we renew our registered trade name and logo. The Adjutant has done so. Another letter from a company in Virginia offering Southern Crosses of Honor for sale was received. Other correspondence was routine administrative memoranda from GHQ and the Camps.

The Recruiting officer gave the annual recruiting and retention report. Each camp received copies of the report and of the list of delinquent members.

Commander Montgomery read his report, a copy of which will be included in the Reports Book at the SCV National Convention in Hot Springs, Arkansas.

Division Graves Registrar John Potenza gave a report on the recently implemented graves registration program.

The Gadsden Brigade Commander gave his report while the Jefferson Davis Bri-

gade Commander deferred his report to the Brigade's camp commanders.

The Camp Commanders gave their reports highlighting their Camps' activities over the past year, to include recruiting/retention, fund raising, heritage events, etc.

The Time and Place Committee: The delegates selected the Colonel Sherod Hunter Camp 1525 as the host Camp for 2010.

Old Business concerned discussion of Sesquicentennial events. Commander Perkins reported that he was contacted by an individual from Arizona State University about the events. He will follow up and report at the DEC meeting. Adjutant Tipton reported that he contacted the Sierra Vista area state Senator and Legislators but has had no response.

In New Business, the delegates considered several items of business as listed below.

1. The Cadet Membership program was stressed.
2. Commander Montgomery, with the approval of the delegates, appointed Compatriot Don Dybus of Camp 1202 as the Division Judge Advocate General.
3. Commander Montgomery, with the approval

Adjutant's Report

Compatriots,

Our 15th Annual Arizona Division Reunion & Convention is past and the 114th National SCV Reunion & Convention are history. Both were outstanding events. I was particularly pleased that our Division had its largest delegation ever to the national convention.

Please see the article elsewhere in this newsletter about the convention.

It's that time again! Dues became payable on 1 August and must be paid by 31 October. This year, the Division is implementing the Membership Renewal System (MRS). It was discussed in an article in the last issue of *The Confederate Veteran* and is also described in the article about the national convention in this issue of *The Rebel Yell*. Basically, the system will send an annual dues statement to each member, stating exactly what is owed in dues. It will include a return envelope and payment coupon. The coupon is addressed to the individual's Camp Adjutant. The Adjutant, in turn, will retain the Camp dues and any donations to the Camp. He will remit the national per capita tax to

GHQ and the Division dues and donations for the optional giving categories to the Division Adjutant. The Division Adjutant will remit any donations for national programs to GHQ and retain the division dues and donations for operating funds and special programs within the division. This system has worked very well in other divisions and has resulted in an increased renewal rate and increased voluntary donations. We will also send statements to delinquent members who have dropped out in the last five years. This will make the Adjutant's job just a little easier. If you haven't received a statement yet, you will have one soon.

RECRUITING

This year's recruiting efforts have gone well. Two of our members were recognized at the national convention with Dixie Club Bronze and Silver medals for their efforts in bringing new members into our ranks. As of 1 August, our strength in full members stood at 200. Camp 2316 is the largest Camp with 50 members. Camp 1710 is second with 40. Now let's use the MRS system and work on retaining

each and every one of those 200 members! I have attached the recruiting and retention summary below. The first column is the number of members as of 30 June 2009. The total in the second to the last column is the number of members as of 1 August 2009. This figure does not include Associates, Dual Members (except for Compatriot Booth who is a dual member in two Arizona camps) or Cadet members.

As I travel around the Army of Trans-Mississippi Department, I am pleased to note the complimentary remarks and praise given to our Camps and Division by others in the ATM. Commander Montgomery and I were sought out in Hot Springs for our advice and suggestions based on the Arizona Division's success. Y'all have done us proud!

Another success is that the Arizona Division is leading the divisions in the ATM in implementing the MRS system. Compatriot Jeff O'Cain, who heads the effort, has repeatedly complimented us.

Hot Springs, Arkansas 22-25 July 2009

The Sons of Confederate Veterans met here in this Arkansas resort for its 114th Annual Reunion and Convention. The event was hosted by the James M. Keller Camp 648 and was held in the historic Arlington Hotel.

This year, the Arizona Division sent its largest delegation ever. Camps 1202, 1710 and 2096 were represented. In addition, Richard Montgomery, the Division Commander, and Jim Brown, Arizona's Real Son, attended.

The convention began with registration on Wednesday, 22 July. However, most Arizona delegations had arrived the night before.

Thursday's session began with a breakfast hosted by the Forrest Cavalry Corps, an honorary organization open to any SCV member. The speaker gave a very interesting description of General Forrest's career. The convention opening ceremonies were held at 8:30 AM. A color guard from the Arkansas Division presented the colors. The Chaplain-in-Chief gave an invocation and the delegates were seated. The Mayor of Hot Springs, the Manager of the Host Hotel, the

Arlington, the President of the Hot Springs UDC chapter, the President-General of the Children of the Confederacy and the immediate Past Commander-in-Chief of the Sons of Union Veterans of the War of Northern Aggression presented greetings. Two Real Sons were introduced. Jim Brown of Captain Hunter's Arizona Rangers Camp 1202 and Marion Wilson from Texas.

The business session included the acceptance of the minutes of the 2008 convention, the adoption of the FY2009 budget and reports from the Commander-in-Chief, the Lt. Commander-in-Chief, the Adjutant and the Executive Director. Past CinC Ron Wilson presented a short report on the 2010 convention to be held in Anderson, SC. The Adjutant-in-Chief also gave a short summary of the MRS (Membership Renewal System). A full workshop will be given on Saturday.

Friday's business session included a report from the Virginia Division concerning the restoration of Oakwood Cemetery in Richmond. The City of Richmond has, after 14 years, finally turned control of the Confederate section over to the Virginia Division and the SCV. CinC

McMichael signed the documents and presented them to the Virginia Division this morning. A wonderful video presentation was given. Each of the 17,200 graves will receive upright markers with names and units where known.

CinC McMichael announced plans to build an office building and CONFEDERATE museum on the Elm Springs property. This building will house the administrative offices, storage spaces, gift shop, etc. that are currently in the mansion at Elm Springs. Fund raising has begun.

CinC McMichael announced the formation of the SCV Sesquicentennial Society. Membership is open to any SCV member. The membership fee is \$200.00--a little pricey—but \$150.00 goes toward the building fund (see paragraph above) and \$50.00 goes into a fund to help finance the Bicentennial activities. More information will be forthcoming.

The Time and Place Committee gave its recommendation for the 2012 Convention site. The committee recommended that the bid from the Murfreesboro, TN Camp be accepted. The delegates voted to do so.

2010 Convention: Anderson, SC
2011 Convention: Montgomery, AL
2012 Convention: Murfreesboro, TN

The Dixie Defenders Camp from the Florida Division proposed the adoption of the Confederate POW flag. The measure was defeated. Many of the delegates liked the idea but did not like the flag's design. Others objected, saying that we already had a flag for our POWs/MIAs/KIAs and that was the Battle Flag.

CinC McMichael reported on his frustration in finding a bank to provide us with an affinity credit card. Every bank that has been approached

refused because of the Battle Flag being part of our logo. It was recommended that we find a bank that would pay us a suitable return, adopt a design that did not include the Battle Flag or logo BUT leave space on the card to affix a permanent decal with the logo. This decal will be provided free of charge by GHQ. The measure was approved.

The Army of Trans-Mississippi met on Saturday morning prior to the final business session .

The ATM won the award for the most number of new Camps. Also, the ATM had the largest representation of the three departments at the convention.

ATM Chaplain Len Patterson gave a talk about recruiting and retention.

ATM Executive Councilman Paul Gramling discussed recruiting and retention as well.

ATM Lt. Commander Brent Jacobs discussed the ATM website and newsletter. He asked that each Camp and Division in the ATM make sure that their websites are up to date. He also requested that each Camp and Division send articles and photos for the ATM newsletter

The ATM Adjutant reminded all that he has ATM lapel pins for sale. The email address is on the ATM website.

Compatriot Mark Vogel of the Texas Division reported on the plans of the Texas Division to hold a special educational event 27 Oct-1 Nov 2010. ALL DIVISIONS are invited to participate. Divisions are

asked to provide historical references to events that took place in their state not only during the war but in the years leading up to it. Scholarly research guidelines apply--all works must be documented/sources and resource cited, etc. No simply downloading a Wikipedia article and submitting it. In fact, use of Wikipedia as a source is discouraged. The event will be held in Gilmer, TX and will cost \$120.00 per person to participate (submission of scholarly works for the event is at no cost but attendance will be as quoted above.) Compatriot Vogel is the point of contact. More details will be provided.

ATM Field Rep Curt Tipton gave a summary of his activities to date and requested points of contact for each division and a schedule of upcoming events.

ATM Commander Todd Owens gave a short report and garnered support from the ATM to defeat Amendment #3.

The business session began at 9:30. Heritage Promotion Committee Chairman Ed Butler (TN) gave a report and offered the following suggestions for forwarding the colors. Ads in auto racing programs; ads in horse racing programs; recruiting students who receive our school programs to join us in living history or other projects concerning grave maintenance, etc.

He also covered the guidelines for installing flags (such as the one in Tampa) will be added to the SCV website and are now available from GHQ in printed form.

The delegates then considered the proposed amendments to the SCV Constitution and Standing orders. Please refer to the last issue of the Confederate Veteran for the text of the amendments.

Amendment 1 Disciplinary Committee: Amended to read: add after ...three Department Commanders and the Executive Councilmen, subject to the consent of the General

Executive Council. Strike the last sentence The Disciplinary Committee Chairman shall not be a member of the same department as the Commander-in-Chief. **PASSED AS AMENDED.**

Amendment 2 Reword Article 2.1 to define the organization: **WITHDRAWN**

Amendment 3: Change the requirement to charter a Camp from 7 to 15 members. **DEFEATED**

Amendment 4 Concerning disciplinary action: **PASSED**

Amendment 5 Change the term of the CinC and Lt. CinC to three years, leaving the department commanders and councilmen at two years: **DEFEATED**

Standing orders amendment #1: Allow more efficient investment of funds: **PASSED**

Standing orders amendment #2 Create a Convention Planning Committee as a standing committee:

Amended to add the Chief of Protocol to the Committee. **PASSED AS AMENDED.**

Standing orders amendment #3 Eliminate the Time and Place Committee: **PASSED.** Convention Planning Committee in amendment #2 takes its place.

Standing orders amendment #4 Make the Heritage Promotion Committee a standing committee:

PASSED

Standing orders amendment #5: Make the Youth Enhancement Committee a standing committee:

POSTPONED INDEFINITELY

RESOLUTIONS:

A resolution to commend the Host Camp, James M. Keller , Camp 648 of Hot Springs for their efforts.

PASSED

A resolution to condemn the misuse of Confederate flags and symbols by extremist groups/individuals:

PASSED

A resolution to impose an economic boycott of the city of Jonesboro, TN

for their refusal to acknowledge Confederate veterans in their veterans memorial (they are engraving "civil war" on both Union and Confederate veterans bricks rather than the proper designation). **PASSED** A resolution in tribute to the Late Compatriot Russell E. Darden:

PASSED

A resolution to allow ONLY Confederate flags in heritage/living history/educational displays: **DEFEATED**

DEFEATED

A motion was passed to make resolution #2 (misuse of CS symbols) a permanent statement of policy for the SCV.

The business session adjourned. Following the business session, Commander Montgomery, Commander Middleton and I attended a meeting concerning the Membership Retention System (see the article in the last Confederate Veteran). The AZ Division delegates decided to pursue this system. It offers several advantages over the proposal made at last year's convention.

1. The MRS will print and mail the statements for us (Associate members WILL NOT be included as they are not in the GHQ data base).
2. We may add appeals for donations to specific Camp and Division projects
3. Members will mail their dues payments and any donations directly to the Camp adjutant.
4. The Camp Adjutant will, in turn, deduct Camp dues and donations to Camp projects and remit the national per capita taxes to GHQ and the Division dues to the Division Adjutant.
5. The Divisions already participating reported a significant increase in renewals and reactivations (we can send these statements to delinquent members) and an increase in donations to Camp and Division projects.

There is an upfront cost for printing/mailling and return envelopes but small divisions such as

The Adjutant read the minutes of the last meeting, gave the financial report, read the correspondence received and gave the recruiting and retention report. Division strength as of 22 August stands at 202.

The Division officers' reports, Brigade Commanders' reports and Camp Commanders' reports were waived. The Time and Place Committee reported that they were still reviewing venues for the 2010 Division convention. The Graves Registration Committee reported on the progress of the Division's Graves Registration system.

In old business, members discussed the upcoming sesquicentennial and a scheduled meeting with the New Mexico Division to plan joint events. Commander Montgomery and Adjutant Tipton will attend. The meeting will be held at the reenactment of the Battle of Valverde at Socorro. Contact has been established with the Tucson Histori-
