please let us support them as much as possible. The ladies have more than earned it.





# 113th Annual S.C.V. Reunion!

The Sons of Confederate Veterans held its 113th Annual Reunion and Convention in the Cabarrus County Event Center in Concord. This venue was the site of the special convention held in 2005 to fight the coup attempt.

The convention opened with an impressive ceremony in which the flags of the various states and territories of the Confederacy were presented. Each flag was escorted forward by the color guard and presented to the assembled GEC. Adjutant Curt Tipton was honored to carry the Arizona Division colors in the ceremony. Following the presentation of the state flags, the US and CS colors were honored. The Chaplain-in-Chief gave the invocation.

Lt. General and Mrs. Thomas J. "Stonewall" Jackson gave a special presentation. They were followed by Mrs. Sarah Powell who presented greetings on behalf of the North Carolina Division of the UDC for President Ruthann Bond. Children of the Confederacy President General Ms. Rebecca Wnydowski gave greetings as did the North Carolina SCV Division Commander Tom Smith,

the North Carolina Order of the Confederate Rose Society President Laura Stoddard, Concord Mayor Scott Padgett and Mt. Pleasant Mayor Troy Barnhart.

Arizona Real Son James Brown of Camp 1202 was introduced to a standing ovation.

The Credentials Committee reported 155 Camps represented with 34 from the ATM, 57 from the AOT and 64 from the ANV. A quorum was declared.

After some debate, the rules of conduct were adopted. The agenda was adopted. The minutes of the 2007 convention were amended and adopted as amended.

LTC(Ret) Ben Sewell, the Executive Director, gave his report. The highlights of his report are:

- Membership currently stands at 29,992 with 51 Real Sons, 3290 Life Members and 257 Cadets.
- There has been a net loss of 3,000 members over the last four years.
- There are 57,000 delinquent members.
- The appeal for donations for the Jefferson Davis statue netted \$6110.00
- The FY 2007 Income & Expenses were:

Expenses: \$922,611.00

- The audit for FY 2006 is complete.  
Income: \$1,270,498.00  
Expenses: \$1,251,471.00  
Income includes interest from invested funds.

The proposed budget for fiscal year 2008 was presented for approval.

Other: \$255,900.00  
CV: \$3,000.00 \*  
Youth Camps: \$30,000.00  
Total: \$1,100,400.00

The Heritage Defense Chairman gave his report (copy available from the Adjutant)

The Time and Place Committee proposed that the location for the 2011 Convention, the 150th Anniversary of the Confederacy, be held in Montgomery, Alabama, 20-24 July, 2011. The proposed registration fee is \$45.00. The proposal was accepted.

The Department Commanders gave their reports. (copies available from the Adjutant)

The first business session adjourned at Noon.

Friday's business session opened at 9:00 AM. The first item of business was a resolution condemning the Wingate/Windham Hotel for a heritage violation. Kentucky Division Lt. Commander Basil Childress displayed a Battle Flag in this room window. The management told him to remove it. He refused to comply as there had been no complaints and no prohibitions against the display of the flag prior to this incident. He was then charged with criminal trespass, arrested, taken to the police station, cited and released. Nearly 50 compatriots who were also staying at the hotel immediately moved out. The resolution passed unanimously. The GEC will announce what retaliation will be taken at a later date.

The delegates then

turned to the proposed amendments to the constitution.

- Amendment 1 Cadet Dues: heavily debated. A standing vote was taken and the chair determined the measure passed. The vote was challenged and it will go to a paper ballot on Saturday.
- Amendment 2 IRS; passed
- Amendments 3-8: failed
- Amendment 9 disciplinary action for a member who brings a lawsuit against the SCV: Referred to the GEC

The Sesquicentennial Committee gave its report and presented the special logo to the delegates. (copy of the report available from the Adjutant)

The delegates considered five resolutions. They are:

- A resolution to commend the convention host camp: passed
- A resolution requiring the GEC to establish a code of conduct for the Confederation: passed
- A resolution to ensure that Departments, Divisions, Brigades and Camps when referring to the Civil War (sic) and Reconstruction (sic) use the terms *War for Southern Independence* and *Occupation of the South*.: passed
- A resolution to support the Jeff Davis Camp 305 of Washington DC in its annual ceremony honoring our President, held since

1914: passed

- A resolution to commend the Concord Police Department for its conduct during the heritage violation. The formal wording was not prepared and the resolution will be on Saturday's ballot.

The Florida Division gave a video presentation on the *Flags Across Florida* project and the huge flag recently installed in Tampa.

The Convention honored Real Daughter Mattie Clyburn Rice, daughter of Weary Clyburn, a Black Confederate soldier from South Carolina. Private Clyburn is buried near Concord and a memorial ceremony will be held to honor him and his service to the Confederacy.

Mrs. Rice was unable to attend due to illness but her children, grandchildren and great-grandchildren were present. There was live TV coverage of the event.

# Adjutant's Report

Compatriots,

It was my distinct honor to represent the Arizona Division at the recent SCV National Reunion & Convention. (see the report on page 2). I wish that many more of y'all have the opportunity to attend a national convention. It is a wonderful experience.

## Dues Collections

Once again, it is that time of year! The national per capita tax, Division and Camp dues became payable as of 1 August 2008. Y'all may recall that the 2007 SCV National Convention delegates voted to increase the national per capita tax to \$30.00 per annum. Thus, the total dues and fees our members owe (unless they are Real Sons, Cadets or Life Members) is \$42.50 assuming one's Camp has \$5.00 dues. Two of our Camps do not have dues—1647 and 2127—thus their members pay \$37.50. Real Sons do not pay dues. Cadets pay \$10.00 per annum and Life Members pay only Division and Camp dues (\$12.50 or \$7.50 depending on the Camp).

## Recruiting and Retention

I won't address retention other than to say that each Camp must vigorously work to retain our quality members. After 31 October, we will know how well we have done.

In Recruiting, we have contacted 17 gentlemen and five have joined either as full or associate members. Three gentlemen have transferred into an Arizona Camp. The breakdown by Camps is: 1202; 2 Full Members, 1 Associate 1525; 0 1647; 0 1708; 0 1710; 1 Associate 2074; 0 2096; 1 Full Member 2127; 3 Transfers In

## Delinquent Members

CinC McMichael has made reactivation of membership of delinquent members one of his goals for FY 2008. Overall, the SCV has 57,000 past members who are eligible to reactivate their membership. Each Camp has been provided with a list of those eligible who live in Arizona. Let us work diligently to return these gentlemen to the ranks.

## Life Membership

I encourage y'all to consider life membership in the SCV. The cost varies depending on your age but, overall, it is a savings to you. At \$30.00 per annum national per capita tax, it only takes a few years to realize a savings in dues payments! Details of the Life Membership fees and payment schedule are on the

application for Life Membership. It may be downloaded from the SCV website at [www.scv.org](http://www.scv.org).

## I.R.S. Filing

I remind all Camp Commanders and Adjutants that the electronic IRS filing of Form 990 **must** be completed no later than 15 December 2008. The process is simple. It may only be done on-line. Go to <http://epostcard.form990.org>. You must have your Camp's employer identification number (EIN) available. If you don't know what it is, email Ms. Stephanie Bible at [atmdesk@scv.org](mailto:atmdesk@scv.org) and she will provide it for you. Follow the steps outlined on the website and complete your filing. It takes about ten minutes. Remember, this is a "no BS" annual requirement of the IRS and must be completed at the end of each fiscal year.

the office of Lt. Commander-in-Chief. They are Michael Givens of South Carolina and Ed Butler of Tennessee. Compatriot Givens was elected.


The delegates also voted on Amendment 1 Cadet dues and defeated the measure. Cadets now pay \$10.00 annual dues.

# Division Executive Council Meets!

Chandler, A.T. 20 September 2008

Division Commander David Barton the first DEC meeting of the 2008-2009 term, today at the Marie Callendar Restaurant in Chandler.

The meeting opened with Honors to the Colors, an invocation and the reading of The Charge. Commander Barton announced that he had received deployment orders and would depart for his new duty station on or about 1 November 2008. At that time, Division Lt. Commander Rich Montgomery will assume command until such time as Commander Barton returns or his term of office expires.

The Past Division Commanders present assembled and Past Commander Bobby Morris presented Commander Barton with the Division Commander's badge of office. Adjutant Curt Tipton then presented the Division's Charter to Commander Barton. The DEC determined that the Division Commander will hold the charter and upon the end of his term of office, relinquish it to his successor.

The Adjutant read the minutes of the Division Convention, gave the financial report and read the correspondence received. He also announced that the Division directory will be published in November, following the termination of the dues collection

IRS electronic filing requirement must be met by 1 December 2008.

The Division staff officers' reports were waived. The Gadsden Brigade Commander provided a written report and the Jefferson Davis Brigade Commander deferred his report.

The Time and Place Committee reported that they were considering holding the 2008 Division Convention at the Maverick King of Clubs in Tucson where the 2007 meet was held. No firm decision has been made.

Adjutant Tipton and Commander Morris reported on the events at the recent national convention (see article on page 3).

Moving to old business, the DEC once again tabled the proposal for placing a plaque denoting the 1861 Secession Convention held in Tucson until more definitive information is available.

Commander Barton reemphasized Past Commander Mangum's Administrative Memo 5-06 which requires the Camps to submit "After Action" reports when taking part in events.

In new business, the council defeated a proposal for centralized dues collection much to the relief of the Adjutant! The Commander-in-Chief's General Order #1 concerning the sesquicentennial of the War for Southern Inde-

pendence was discussed. Further action by the Division was tabled and the matter was referred to the Camps for their input. A proposal to establish an Associate Member camp was withdrawn. It was acknowledged that the Associate Member program is the prerogative of the Camps. A proposed uniform manual was presented and accepted as guidance for the wear of uniforms and decorations.

The council voted to reopen the Division Disaster Relief fund and to forward contributions to GHQ's disaster relief fund. The Adjutant will determine an end date for contributions.

A proposal to purchase a Division flag for the Division—the only Division flags in existence belong to the Camps—was passed. Ms. Carla Pyle, associated with the Colorado Division has offered to make the flag for \$150.00. The Adjutant was directed to cut a check and forward our order to Ms. Pyle. Camp 1710 will donate a staff and the Division Color Sergeant will take charge of the Colors.

The Council passed a measure authorizing the organization of a Ladies Auxiliary. Mrs. Tammy Perkins has kindly volunteered to chair the organization effort. Each Camp is asked to email Mrs. Perkins the names, addresses, email addressed and birth day and month (no year, please!).

Adjutant Paul Mears of

Camp 1202 proposed the creation of an honorary society similar to the Order of the Sabre and the Order of St. Barbara. This society would be for the descendants of Confederate infantrymen and would be known as the Society of the Order of St. Maurice—the patron Saint of the Infantry. The society badge would be the Infantry horn on a light blue background. The measure was passed. Commander Perkins has a vendor that can make the badges and he will contact them for the Division.

Commander Montgomery presented a request from the American Legion for the Division to sponsor a hole on the Sons of American Legion Squadron 36's golf tournament in Tubac. It was approved by the Council and the Adjutant was directed to send our check to the American Legion.

Commander Meek offered a proposal to donate money for materials to make tent poles for the new tent used for administrative and other purposes by the Picacho Peak State Park staff during the "Civil War (sic) in the Southwest" event. The council approved the expenditure of \$150.00 for the project.

Adjutant England of Camp 2096 announced that the Graham County Fair parade will be held on 10 October in Safford and that the Camp has entered. He invited all other Camps to participate.

Adjutant Tipton informed the council that Camp 1710 had entered the Helldorado Days parade to be held on 19 October in Tombstone. All Camps are invited to participate. The entry will include the Division Color Guard, a surrey for the ladies, marching infantry and a cavalry escort. Compatriots wishing to rent horses should contact Adjutant Tipton.

The American Heritage Festival will be held at Queen Creek on 14-15 November. Registration forms are available on the "We Make History" website or from Commander Perkins. Commander Perkins also announced that a large reenactment event will take place at Fort Tejon, California in November and offered rides to the event. Contact Commander Perkins for information.

Camp 1525 will host the annual Jefferson Davis Memorial Ceremony on the 1st Saturday in December. Further information will be provided as the date nears.

The "Civil War (sic) in the Southwest will be held on 14-15 March 2009 and there will be a new reenactment event held at Yuma in April.

The meeting closed with a benediction and adjournment at 2:00 PM. Thanks to all who attended and thanks to the staff of Marie Callendar's Restaurant for the good food and great service.

## AZ Division Honorary Societies!

Membership in three honorary societies is available not only to Arizona Division members but to any SCV member. The oldest of the societies is the Society of the Order of the Sabre. Membership is open to the descendants of Confederate mounted soldiers—cavalry, dragoon, mounted infantry or horse artillery.

The Society of the Order of St. Barbara is open to the descendants of Confederate artillerymen—field artillery, siege artillery, coastal or naval gunners and horse artillery.


The newly formed Society of the Order of St. Maurice is open to the descendants of Confederate infantrymen.

Each society member receives a distinctive membership certificate, card and membership badge. The badges are pictured above.


The final design for the Order of St. Maurice badge has not yet been approved. It will consist of the Infantry horn on a blue background. We cannot use the Combat Infantry badge which is similar to the badges for the Order of the Sabre and the Order of St. Barbara as it is an official US Army decoration and, thus, cannot be used. The other "combat" badges are not officially used by the US Army—they were never

adopted for use—so we may use them.

To apply for membership in any (or all) of the societies, send a letter to the Division Adjutant listing your name, SCV #, Camp name and number and your ancestor's name, rank and unit. 
## Camp 1525 Member Hosts CS & US Artillery Estrella Mountain Community College Students Experience the War!

On Monday, reenactors from Arizona and Colorado portraying the 1st Texas Light and 3rd U.S. Artillery Battalions marched onto campus to demonstrate authentic Civil War (sic) weaponry for Professor Robert Massey's history class.

The demonstration included a discussion of the different types of field artillery, the history and development of artillery tactics, the organizational structures of both Union and Confederate artillery brigades and the effects of such artillery on the battlefield.

"Students loved it. They took part in the thing. I've just always been a believer in as much hands-on teaching as you can do," Massey said.

The appearance by the group of 16 War for Southern Independence re-enactors also included a demonstration of actual drills used in firing the Model 1861 10-pound Parrott rifle, one of four cannons used by the reenacting troupe for educational purposes.

"We started our unit approximately three years ago. We have kind of a several-pronged look at this thing," said Walt Nichols, unit commander for the 1st Texas Light Artillery/3rd U.S. Artillery.

"It's an appreciation of history," he said. "We enjoy the devil out of this. I mean, who doesn't enjoy big guns? And we like it when people come up to us and ask us questions. These were smaller people moving heavy stuff in tough terrain. How many people in this day and age can do something like that?" Apparently, the men and women comprising his Civil War re-enactment troupe can.

Aside from the parrot rifle, the unit is able to field two 12-pound Mountain Howitzers on prairie carriages and another 12-pound Mountain Howitzer on a pack carriage.

"They're all a pretty good chunk of metal and wood," which range in weight from 800 pounds to more than a ton each, Nichols said of the weaponry.

The actors also dress in replica Union and Confederate uniforms made from wool. Doing so in the Arizona summer can be an excruciating experience, but "you learn how to dress for it," Nichols said. "Wearing a cotton shirt under a wool jacket is actually not that bad. The shirt actually acts like a cooler because all your perspiration soaks into it," he said.

Massey's students got to sample what it was like to be a Civil War (sic) soldier when they participated in the acting group's demonstration Monday.

"Evidently, there are four positions to fire a canon, and the reenactors went through to show the students all the different steps," Massey explained.

"They went through the whole process, and then said they needed some stu-

dents to take part, so each of the students went through it," he said. "Each student simulated loading a gun, getting it prepared to fire, sighting it, so they kind of got a good appreciation at that time of what it took."

Historical appreciation is what the reenacting troupe is advocating, Nichols said. "We just want people to appreciate what our forefathers did and lived through, so they have a better respect for people from those days, and they do."

Massey said the hands-on history lesson was important for his students to better comprehend the past and understand the present.

"I think it was Ben Franklin who said a people who don't know the history of their past are doomed to repeat it," Massey said. "What I try to do in class is correlate history with events that are occurring today and what we can learn from them. I think there's relativity to it besides just being in class."

While years from now his students may not recall all the details they learned in his American history class, Massey said, "I bet they never forget this."

## 3 Camps Join in Tucson's 233rd Anniversary!

Tucson, A.T. 20 August 2008

Members of Camps 1202, 1710 and 2127 joined Mrs. Ella Stone Mears, President of the Arizona Division of the UDC, in presenting the Confederate Colors at a ceremony celebrating the 233rd Anniversary of the founding of Tucson. All of the flags that have flown over the "Old Pueblo" were presented in the ceremony.

The ceremony began with the firing of a cannon from the reconstructed walls of the Presidio de San Agustin de Tucson by Spanish artillerymen. A Color Guard from the US Air Force Honor Guard at Davis Monthan AFB posted the US flag. A spiritual leader of the Pascua Yaqui tribe gave the invocation. A descendant of a Spanish sol-

dier who served in Tucson read the letter from Colonel Hugo O'Connor, an Irish Mercenary in the service of Spain, who established the garrison at Tucson. The letter was addressed to the Spanish Viceroy. The Chairman of the Tucson Historical Commission read the proclamation establishing the annual ceremony. Officials from the City of Tucson and its suburbs signed the document using quill pens.

The representatives of the To'ono Odom and Pasqua Yaqui tribes presented their flags. A group of Spanish infantry reenactors escorted the Spanish flag forward. The Mexican Consul and two of his staff members presented the flag of los Estados Unidos de Mexico. Members of the Mormon Battalion Association presented a 28 star US flag. The Mormon battalion passed
