## Dispatch from the Commander

Compatriots:

Since the last issue of the *Rebel Yell*, the Arizona Division has accomplished many very worthwhile projects. As Commander of the Arizona Division, I would like to compliment all of you on your efforts to further "The Charge". Let's take a few lines to review some of your accomplishments.

The Lee / Jackson Luncheon, was again well done. All who attended had an enjoyable time I'm sure.

Commander Garrison and Camp 1647, put forth a gallant effort to overcome the negative response of the Yavapai Cemetery Association, when the association refused to allow military headstones to be placed on Confederate Veteran's graves. His tenacity resulted in a reversal of their original findings. The Confederate Veterans will now be receiving the respect that is rightfully theirs. They

will have military headstones marking their resting place.

Commander Ron Fox, and Camp 1708 should be commended for the dedication ceremony of the memorial on Captain Granville Henderson Oury's grave. Unfortunately I could not attend this ceremony, however the Arizona Division was well represented by its camps and their members.

Most recently Camp 1202 submitted an entry to the Fiesta de Los Vaqueros Parade in Tucson. Compatriot Les Cogar spearheaded this operation, and it was well represented by four camps of the Gadsden Brigade. Ten Sons of Confederate Veterans on horseback, dressed in Confederate uniforms led by Confederate Colors made an impressive entry. There were many cheers and salutes as we rode by.

What does this all illustrate? In my humble opinion I believe it shows that

Compatriots of the Arizona Division are out there doing things that honor their Confederate Ancestors. It also indicates we can do good things if we all work together. If we stand united in our efforts the Arizona Division will become a well recognized and respected organization.

# Victory in Prescott!

Prescott, A.T. 7 January 2008

After months of skirmishing and outright battles, Commander Ken Garrison of the Pvt. Peter Hail Camp 1647 reports a victory over the Yavapai Cemetery Association and the Yavapai County Facilities Department. Assisted by Compatriots from across the Confederation and from the ladies of the United Daughters of the Confederacy, Camp 1647 waged an unrelenting attack on the forces of political correctness who denied permission to place appropriate markers on the graves of three Confederate soldiers.

On 3 January, Commander Garrison met with Mr. and Mrs. Atchison of the Yavapai Cemetery Association and representatives of the Yavapai County Facilities Department. At this meeting, an agreement was reached

whereby the graves of our Soldiers would be properly marked. The Facilities Department would order the headstones from the Department of Veterans Affairs and install them.

The grave markers will read as follows:

**H.A. Owen**  
**7th Georgia State Guards**  
**Confederate States Army**

**John O. McNeff**  
**Confederate States Army**

**J.H. Wright**  
**Arizona Supreme Court**  
**Justice**  
**Confederate States Army**

The headstones for McNeff and Wright will not contain a reference to a specific Confederate military unit as their records are uncertain as to which organization they served in. There is, however,

definite proof of their military service to Confederacy.

Commander Garrison is in receipt of a letter from the Yavapai County Facilities Department signed by Mr. Patrick Kirshman, Director, which confirms the agreement reached at the meeting. While Camp 1647 has achieved a victory in this battle, we have not yet withdrawn to "winter quarters." Our reserves and a full battery of 12 pounders are in readiness should any part of this agreement be abrogated by the YCA or the Yavapai County Facilities Department.

The Arizona Division extends its sincere appreciation and congratulations to Commander Ken Garrison for his persistence, dedication and fortitude in carrying this fight to the PC enemy for more than four years!

# Arizona Division Executive Council Meets!

Chandler, A.T., 16 February 2008

The Arizona Division Executive Council held its quarterly meeting today at the Marie Callendar restaurant in Chandler.

After the opening ceremonies, the first order of business was the presentation of awards. Division Commander John Mangum presented the "Best Shot—Breechloader" certificate to Commander Glenn Meek of Camp 2074. Glenn earned this honor at last August's Black Powder Shoot. Commander Mangum then presented an SCV Dixie Club recruiting award to Camp 2127 Adjutant David Barton for recruiting 8 new members and 1 new associate member.

The roll was called and the following were present:

A quorum as defined in the constitution was present.

The Division Adjutant read the minutes of the last DEC meeting, gave the financial report and the recruiting and retention report.

The Time and Place

Committee announced that the Division convention will be held on 7 June 2008 at the Maverick Club in Tucson. The business session will begin at 10:00 AM followed by a buffet lunch. Entertainment has been arranged as well. Cost for the buffet will be approximately \$23.00.

In old business, the Adjutant summarized the results of the special DEC meeting held on 19 January. The purpose of that meeting was to consider adoption of the "Articles of Association" as an amendment to the Division constitution. The measure was approved. Additionally, all eight Camps have adopted the measure as part of their constitutions.

In new business, the DEC took up the question of liability insurance for events such as parades and reenactments. A letter from the attorney representing the Tucson Rodeo Committee prompted the question. The committee is being sued by the family of the little girl killed in a tragic accident in last year's parade. The attorney wanted to know who the liability insurance carrier for the SCV might be. He also implied that Camp 1202 might be in some way partly responsible for the accident. On the advice of GHQ, the Camp responded stating that the Camp had no such insurance and that, according to the Tucson Police Department report on the incident, had no responsibility.

The DEC considered it prudent for the Division to have in place some protection for our Camps and members. Commander Mangum found a com-

pany, the American Equestrian Association, that will allow us, for an annual membership fee of \$50.00, to purchase \$1,000,000.00 coverage for each event in which we participate. The coverage's cost depends on the number of participants, the number of spectators and some other considerations. For example, the cost for 14 participants in this year's Tucson Rodeo Parade is \$225.00. A motion was made as follows.

- The Division join the AEA and pays the annual fee
- Each Camp participating in an event applies, through the Division Adjutant, for liability coverage.
- The participants or the Camp in each event pays the cost for the coverage of that event.
- Since time is short of the Tucson Rodeo Parade, the Division will pay the full cost for coverage for this one event. The participants will reimburse the Division for the cost of the coverage.

The motion was seconded and passed.

Commander Meek moved that the Division eliminate of the offices of Quartermaster, MOS&B Liaison and SUVCW Liaison. During the discussion, it was determined that the office of Quartermaster cannot be eliminated without an amendment to the Division Constitution. However, the Division Commander is not obligated to fill it. The other two offices are not speci-

fied in the Constitution. The motion was amended to read that the liaison offices would be eliminated at the expiration of the current Division Commander's term of office.

The Division had extended invitations to three candidates for national office to attend the DEC meeting to present their platforms. Commander Garry Ayres of the Col. John T. Coffee Camp, a candidate for Army of Trans-Mississippi Commander, was present. He is also the editor of the ATM newsletter. Commander Ayres held a question and answer session and provided handouts outlining his platform. He is opposed in the upcoming election by Louisiana Division Commander Tom Owens.

Unfortunately, the other invitees were unable to attend. They are: Current ATM Commander Chuck Norred of California, candidate for Commander-in-Chief and Commander Kyle Sims of Texas, candidate for ATM Executive Councilman.

Commander Rich Montgomery of Camp 1202 gave the details for the assembly point and time for this years' Tucson Rodeo Parade and announced that Camp 1202 will hold a grave marker dedication ceremony in Evergreen cemetery on 26 April. He invited all Camps to participate.

The meeting was adjourned at 3:00 PM. The next Division meeting will be the Division Reunion & Convention on 7 June 2008 in Tucson. Y'all come, hear!

6. My philosophy about our organization is based on the fact that there is a huge percentage of the population that have Confederate ancestors...our challenge is to reach them and have a myriad of activities or pursuits in order to attract larger numbers. We must have some skilled marketers in our midst that can package us and sell us to the target groups. This survey is a good step towards improving our recruiting and improving participation of the so many great individuals that belong to our camps.

7. My job requires me to travel a great deal. As a result I am a silent member as I am unable to devote myself to active participation. I am none the less a proud life member and more than happy to support the SCV through my annual dues.

Some questions were raised in the various comments. I will address those I can answer here.

**1. Political discussions at meet-**

**ings:** The person commenting said he was uncomfortable with discussions of contemporary political issues, immigrations, race, etc. at SCV meetings. He mentioned the term "darky". Article 2, Nature and Purpose, of the SCV Constitution states that the organization is "strictly patriotic, historical, educational, benevolent, non-political, non-racial and non-sectarian. Article II, Section 1, Nature, of the Arizona Division constitution states the same thing. Further, Article II, Section 2, specifically prohibits partisan political discussions. The SCV's status as a 501(c)(3) non-profit organization prohibits it from supporting any political candidate or party and limits the support it may give to legislative issues. Therefore, contemporary political discussions at SCV meetings are not acceptable. Neither are racist comments.

**2. Why did the National per capita tax increase?** At the 2007 National convention, the Executive Director reported a shortfall in operating funds for the upcoming fiscal year. It was proposed to increase dues by **\$8.00 effective 1 August 2007**. The delegates considered that too short notice for a dues increase and also that the amount should be \$10.00, making the national per capita tax \$30.00. That motion passed with an effective date of 1 August 2008. The shortfall in operating funds for fiscal year 2007 (the one we're in now) will be made up by various economies and cuts in operations. The last dues increase was more than 10 years ago when dues went from \$18.00 to \$20.00.


**3. What do division dues pay for?** The Division has some regular expenses such as the cost of printing and mailing hard copies of *The Rebel Yell*. That particular expense has been cut by sending out the electronic version and could be cut even more if those Compatriots who have not provided email addresses would do so. Other expenses include printing and mailing the Division Direc-

tory (same comments as *The Rebel Yell*) and postage for other mailings. Occasionally, some office supplies are purchased. Other than those expenses, the Division funds are to pay for any projects or other items for which the membership desires to use them.

**4. Serving alcoholic beverages at SCV functions and meetings:** The person commenting was uncomfortable with the serving and consumption of alcohol at SCV events. There is no specific prohibition against such consumption but Article 13, Section 1 of the SCV constitution describes "conduct unbecoming a member of the SCV." Drunkenness and rowdy behavior while intoxicated certainly fall under this section. While there is no prohibition on the serving and consumption of alcohol at SCV events, the boundaries of good behavior and gentlemanly conduct would dictate that members do so in moderation and temper their behavior.

This was the Division's first attempt at a members' survey and it did answer some questions and provide some food for thought for the Division and Camps leadership. We will use this tool in the future to gauge trends and the desires of the membership. If any Compatriot has some questions or suggestions to include in a future survey, please send them to the Adjutant.






Florence, A.T., 16 February 2008






