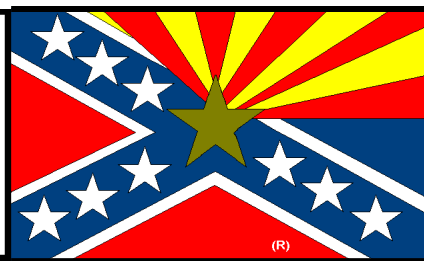

## Dispatch from the Commander

### **HONOR ANSWERING HONOR**

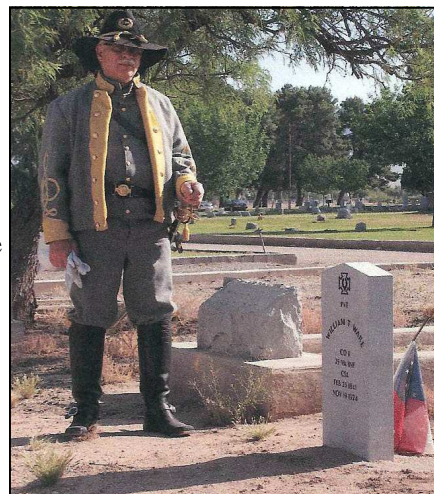
There is a very moving painting by artist Don Spaulding called "Honor Answering Honor," with which some of you are familiar. It depicts an event said to have taken place at Appomattox on April 9, 1865. The story is that the remains of the Confederate army were marching up the road towards the Appomattox Court House being led by Major General John B. Gordon. His burden was great as he moved to perform this last and most painful task. Meanwhile, Brigadier General Joshua Chamberlain, commanding the parade at the formal ceremonies, understands that the occasion must be dignified; General Grant has made that clear. Chamberlain's troops are in formation along the route the Confederates must march. As a gesture of respect Chamberlain has ordered that as each Confederate division reaches a point opposite the right of the Union line, his entire division, regiment by regiment from right to left, will give the soldier's

salutation from "Order Arms" to "Carry Arms!" –the old marching salute.

Gordon approaches "with his chin on his breast." At the sound of the bugle the veterans of Chamberlain's old First Brigade respond, and as the Confederate General hears the rattle of troops coming to the 'Carry', he looks up and at once grasps the meaning. Straightening up, Gordon wheels his mount to face Chamberlain and gently touches the spur, man and horse fused into one uplifted figure. "With profound salutation" he drops the point of his sword to the boot toe and commands successive brigades as they pass to perform the position of the manual-"honor answering honor." It is a moment frozen in time.

As I read over the stories from a family book, I am struck by the dignity that my ancestors possessed in such hard times. Those who fought in the War for Southern Independence did not seek honor for themselves – they sought to protect the honor of their homes, families, and traditions!

One family story tells of a young distant cousin, my great (x4) grandfather's nephew, Wilkes H. Quattlebaum, who hailed from Barbour County, Alabama, near Opelika. In March 1862, at 17, Wilkes joined the Confederate Army at Fort Browder and became a member of Company D, 15<sup>th</sup> Alabama Regiment, known as the Fort Browder Roughs. Wounded at Cold Harbor and again at Chickamauga, he and his regiment were surrendered by General Lee and paroled at Appomattox, where they stacked their arms in front of the courthouse. He and a companion named Roberson, had no funds and began the long trek back to Alabama. They depended upon the generosity of those who lived along the road.

Very few had anything to offer in those hard times! Wilkes said that they went for five days without food, and on the fifth day they came upon a small shed beside the road where a grist mill once stood. Under this shed were strewn a few shuck, which provided a good bed for them. Before retiring for the night, they found a small ear of corn that had been overlooked. They roasted the dry ear of corn, yet they still thanked God for their 'good luck' in finding the delicacy!

Another story involves my 4x great uncle, Paul Quattlebaum, whose plantation, Pinarea, near Lexington, South Carolina, was the target of a Yankee cavalry unit sent specifically to burn it down because he was one of the signers of the Ordinance of Secession for South Caro-

lina. The fire was doused by his faithful servants, saving the house. His wife lived to be 92, and held to her beliefs, and told her great grandson that she had concluded that "I have never yet been reconstructed!"

Amusing stories, and I could go on with many more, but on to the point! They make me wonder what these folks, our ancestors, would make of us today? Would the Sons of Confederate Veterans and all our various endeavors bemuse them? Perhaps. Would they be proud that we remember them? No doubt.

We must carry out our Charge in such manner that it always reflects honor upon them. It always should be "honor answering honor," across all the years, now and forever!

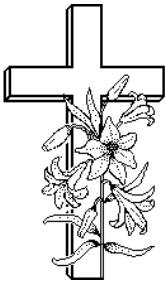

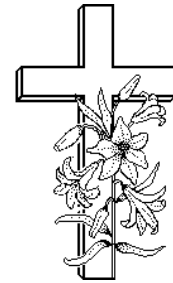

Members of the Captain Granville H. Oury Camp conducted a clean up of the Adamsville Cemetery in Florence. This cemetery is the site of the grave of the Camp's namesake, Captain Granville H. Oury, Arizona's representative in the Confederate Congress, a US Congressman, successful businessman and Confederate veteran.

## **Camp 1710 Joins in the Historic Soldiers Relocation Ceremony!**

Sierra Vista, A.T., 16 May 2009

As Arizona prepares for its centennial as a state (14 February 1912) and for the Sesquicentennial of the War for Southern Independence (2010-2015), the Historic Soldiers Cemetery at the Southern Arizona Veterans Memorial Cemetery has been recognized as one of the first Arizona Centennial Legacy projects.

Being called a cemetery within a cemetery, the nearly one acre plot will become the final resting place for 58 soldiers who died between the 1860s to the late 1880s and were buried in what is now downtown Tucson.

Excavation for construction of a new City and

County complex unearthed the remains a few years ago. An archaeological study was performed and the remains were removed.

Compatriot Joe Smith of the New Mexico Division SCV built 58 coffins so that these soldiers remains could be relocated to the Historic Soldiers Cemetery.

Today, in a ceremony hosted by Mr. Randy Groth, civilian aide to the Secretary of Defense and attended by Governor Janice Brewer, Congresswoman Gabrielle Giffords, Sierra Vista Mayor Robert Strain and other dignitaries, these soldiers were given military honors and placed in their final resting place

Soldiers, sailors, airmen and Marines stationed at Ft. Huachuca and in Tucson

acted as an honor guard, folding the 35 star flags placed on each coffin. The honor guard then carried each coffin to its final resting place.

Music was provided by the 36th Army Band from Ft. Huachuca and by the 4th Cavalry Regimental Band of Tucson. The rendition of the 1880s version of *The Star Spangled Banner* was impressive and the echo version of *Taps* brought tears to many an eye. The Fort Huachuca Honor Guard fired an artillery salute. Boy Scouts from the local troops provided assistance in setting up the ceremony.

Also taking part were members of the John R. Baylor Chapter 2298, UDC, members of the Southwest Association of Buffalo Soldiers,

The Picacho Peak Camp #1, SUVCW of Phoenix was conspicuous by its absence. The editor finds it beyond belief that the only SUVCW Camp in Arizona could not be bothered to travel here to honor these soldiers—many of whom were members of the California Column.

Governor Brewer and Mayor Strain presented proclamations to Cemetery Administrator Joe Larson and Sergeant Major (Ret), USMC, Norm Sponcie, presented a framed, folded 35 star flag to Mr. Larson on behalf of a coalition of veterans organizations in the community.

The ceremony concluded with the placing of the coffins containing the remains in the newly dug graves in the Historic Soldiers Cemetery. Nearly 800 people attended the ceremony.

## **Camp 1710 Represented in New York Memorial Day Parade!**

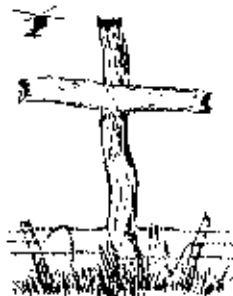

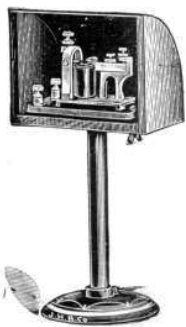
