## Dispatch from the Commander

The Arizona Division, man for man, can be held against any other division in the Confederacy! We are a very active group! In reviewing the past year, I found it full of activities, discounting regular monthly camp meetings; we are more likely to have joint events than singular one-camp events. The start of this current year was very typical with four camps being represented at the Camp 1525-hosted Lee-Jackson luncheon in Phoenix, plus the John R. Baylor chapter of the UDC gave us a turn out of around forty people!

I believe that our most encouraging event of the past year occurred on December 4, when some thirty SCV and UDC compatriots gathered at the Jef-

erson Davis monument on Arizona highway 60 near Apache Junction. This was a patriotic response to a possible expansion of the highway by ADOT and concern that the monument was being overlooked or ignored by the state. It is heartening to know that the Arizona Division of the SCV, along with the UDC, can rally to defend our heritage, and it is one of many events we can look upon with certain pride.

Numerous events had joint camp/UDC participation and support: Pica-cho, Confederate Memorial Day, Dragoon Springs, Annual Division Convention in Phoenix the National Convention in Anderson, South Carolina, Tucson's 235<sup>th</sup> Anniversary, Helldorado Days Parade in Tombstone, Graham County Fair in Safford, participation in the UDC state convention at Westward Look Resort wherein participants met Bertram Hays-Davis (a great-great grandson of Jefferson Davis), Veterans' Day parades, and so on. Certainly not a full listing of all the activities and achievements, but it gives one a clear idea of the span of activities in which we all find ourselves engaged.

# Division Executive Council Meets!

Tucson, A.T. 12 February 2011

The Arizona Division Executive Council held its quarterly meeting at Daisy Mae's Steak House in Tucson. The meeting was hosted by the Captain Hunter's Arizona Rangers Camp 1202.

After the opening ceremonies, Division Commander Richard Montgomery assumed the chair. The Division Adjutant read the minutes of the last DEC meeting, gave the financial report and the recruiting/retention report.

The Time & Place Committee provided further details on the 2011 Division Convention and the Sesquicentennial Committee reported on upcoming events, particularly the reenactment of the Tucson Secession Convention. Commander Cogar of Camp 2127 reported that the entry for the Fiesta de los Vaqueros parade has been submitted and invited the other Camps to participate.

Gadsden Brigade Commander Meek submitted a written report of the Brigade's activities over the past quarter.

In old business, the Adjutant reported that a meeting was held to organize a new Camp in Yuma and that we could expect the charter application to be submitted by the end of the month.

The proposal to change Camp 1647's status from the Division HQ Camp to a regular Camp and appoint past Camp 2316 Commander Ken Garrison as the Commander was rejected. Camp 1647 will remain the Division HQ Camp under the provisions of the Division constitution.

In new business, it was moved, seconded and passed to establish bank accounts for our Graves Preservation Fund and Sesquicentennial Fund. Currently, the money for these funds is kept in the general fund. The motion was passed and

the Adjutant was directed to open these accounts.

Commander Montgomery discussed recruiting efforts and strategies. The DEC members had several suggestions concerning this vital effort. More will be forthcoming concerning this matter.

Camp 2127 Commander Bill Martini and Gadsden Brigade Commander Glenn Meek presented Compatriot Kenneth W. Polley's War Service Medal to Camp 1710 Commander Silas Griffin. Compatriot Polley, now deceased, was a charter member of Camp 1710. (See the article in Camp News.)

Camp 1710 Chaplain Jack Griffin gave the benediction and played a hymn on his harmonica.

Commander Montgomery adjourned the meeting at 12:00 Noon and lunch was served.




**F. Pendleton Gaines**


1944-2011

# Jefferson Davis Memorial Safe!

*The following letter was sent electronically to the President of the Arizona Division UDC, Ms. Janet Grams and to the Adjutant of the Arizona Division SCV.*

## US 60 Alignment Study, Superstition Freeway to Florence Junction

Thank you for your recent communication to the Arizona Department of Transportation regarding the US 60 Alignment Study, Superstition Freeway to Florence Junction. Your communication expressed concern regarding potential impacts from the US 60 Alignment Study project to the Jefferson Davis Memorial, a historical memorial located at the junction of US 60 and Peralta Road.

As described in the final environmental assessment for the US 60 Alignment Study, the *Gold Canyon Re-alignment Option 2*, which is the alternative to be carried forward (Build Alternative), would not result in any roadway impacts in proximity to the US 60/Peralta Road intersection, and therefore would not affect the Jefferson Davis Memorial. As such, formal recordation and evaluation of the eligibility of the memorial for inclusion in the National Register of Historic Places was not undertaken for this project.



We greatly appreciate receiving the comments and information pertaining to the Jefferson Davis Memorial. Should you have any questions, please do not hesitate to call or e-mail me.

# Granville Henderson Oury



Captain Granville H. Oury

Oury, the son of Augustus Oury was born in Abingdon, Virginia on March 25, 1825. He was a younger brother of William Sanders Oury. Oury migrated with his family to Pike County Missouri in 1843 where he studied law and was admitted to the


bar in 1848. The following year he moved to Los Angeles, California where he practiced law until 1856 when he moved to Tucson, Arizona where he joined up with his brother William. In addition to establishing a law practice he also owned and operated sev-

eral mines in southern Arizona.

He served as Chief Justice in a provisional government and was active in efforts to obtain territorial status for Arizona.

In 1857, a group of



Americans known as filibusters led by Henry Alexander Crabb, a California state senator, entered the Mexican state of Sonora in an attempt to help the state secure independence from Mexico. After a six day siege, Crabb surrendered his men believing they would be returned to safety across the border. Oury gathered up a group of men and headed to Sonora in an effort to rescue Crabb and his men. It was too late, all 59 survivors had been executed and Oury's group had to fight its way back to the border, losing four men.

After Lieutenant Colonel John R. Baylor invaded the New Mexico Territory in 1861 and defeated the only Union forces in the southern half of the territory, he declared Arizona to be a Confederate Territory and made himself governor. On August 6, 1861, Governor Baylor appointed Oury as Arizona's delegate to the Confederate Congress.

In 1862 Oury enlisted in the Confederate Army serving in Captain George Frazier's Arizona Rangers, also known as Company B, Herbert's Battalion, Arizona Cavalry. When Frazier was promoted to Major, Oury was elected as Captain. By July of 1862 the Confederate forces had moved out of Arizona and New Mexico and Oury's unit was serving under Brigadier General Henry Hopkins Sibley in Texas and Louisi-



ana.


After taking part in the Bayou Teche Campaign against Union Major General Nathaniel Banks in the spring of 1863, Oury asked to resign his commission. Upon receiving permission from Sibley to resign he went to San Antonio, Texas where he married his cousin Mina Sanders.

At the war's end, Oury fled to Mexico with his wife. After wandering around the state of Chihuahua for a couple of months they returned to Arizona and at Fort Mason did what he had sworn to never do. He took the oath of allegiance to the United States on October 8, 1865.

He was elected to the Arizona Territorial legislature in 1866, 1873 and 1875. In 1869 he was appointed to the post of Attorney General of the Arizona Territory. At some point he moved to Florence, Arizona and while living there he was twice elected as Arizona's delegate to the

United States House of Representatives. He has the unique distinction of being the only man to serve as a territorial delegate to both the Confederate Congress and the United States Congress. He also served as a delegate from the Arizona Territory to the Democratic National Convention in 1884.

After his tour in Congress he returned to Florence and practiced law until he died of throat cancer on January 11, 1891. He is buried in the old Adamsville Cemetery in Florence which served Florence and the extinct community of Adamsville. He is also the namesake of the Sons of Confederate Camp 1708 of which the author is a proud member.

He was born on Christmas Eve, 1914. Jack worked with the Civilian Conservation Corps during the 1930s and enlisted in the US Army Air Corps in 1942. He arrived in France after the D-day landing and served until the end of World War II. After the war, he became an ordained minister and worked as a missionary in the US, Cuba and Mexico. He and his son, Camp 1710 Commander Silas Griffin, co-authored a book about Jack's life and experiences. 
## Camp 1525 Hosts the Jefferson Davis Memorial Ceremony!



The US Federal Army is known to have had at least 94 "Travelling Lodges" attached to various of its regiments. (The Confederates had 150.) These Lodges used special warrants enabling them to hold meetings where and when they saw fit. 'Travelling Lodges' were particularly active prior to the Civil War. For example, the records of Rocky Mountain 205, warranted by the Grand Lodge of Missouri, show that in just one period March– December, 1859, it initiated 54 candidates. Rocky Mountain also stands as an example of the divided political opinions that existed in the country.

At the outbreak of war in 1861, the Lodge's senior warden, Henry Heth, joined the Confederate Army while the master, John C. Robinson, remained to become a General in the Federal Army. About 11% of the members of the Federal Armed Services were Freemasons, and of the Confederates, approximately 12%.

During the battle of Douglas Church, which took place in April, 1863, Captain Gray, a Georgia Freemason, was ordered to attack the Federal troops and to take no prisoners. During the melee he raised his pistol at a Northern trooper who, realizing the hopelessness of his situation, gave a Masonic sign. Disobeying his Colonel's orders, Gray escorted the captured soldier to safety at the rear of the Confederate lines.

Brother Captain Rankin, a Freemason from Mississippi, was killed as he led his Company in an attack on Federal positions at Atlanta. Due to the ferocity of the battle, his men had to retreat before they could retrieve his body. As night fell, Confederate Freemasons heard a familiar hymn being sung in the Federal lines. Those who knew the words took it up. Some time later, a Yankee officer, bearing the personal belongings of Brother Rankin, entered the Confederate lines under a flag of truce and brought the news that the deceased brother had been interred with full Masonic rites.

Many thousands of men, on both sides, became prisoners-of-war. Naturally, there were Freemasons among their numbers. In many of the POW camps brethren formed Masonic Associations to assist each other and the other prisoners. One such group was active in the Johnston's Island Prison Camp. Among the thousands of Confederate prisoners held here, some 600 brethren formed a Masonic Association. It held lodge meetings, as well as conducting benefit nights and a debating society. Since many of the prisoners could neither read nor write, the Masonic group established an educational program on their behalf.


