## Dispatch from the Commander

### **FOUR FOR FOUR**

I was proud to ride with my brother SCV cavalymen in the 87<sup>th</sup> Annual Tucson Rodeo Parade on February 23, last. There were four horsemen. Compatriots Larry Bowman of Camp 1710, Bobby Morris and Steve Ledbetter of Camp 1202, and I made up the foursome. The spectators were reported at 150,000 by different news sources. My hat is off to these gentlemen for riding in the parade, representing the SCV and their ancestors. I know each of them and they all have given in great measure, in time and money, to their camps and to the Arizona Division of the SCV. And, they all have measured up to our Charge by their deeds!

In the most recent (March/April 2012) issue of the Confederate Veteran, our Commander-in-Chief puts forward a suggestion that camp commanders consider having four major events in a year; that the year be divided into quar-

ters and one event per quarter be the designated significant event of the quarter. He encourages maximum participation in these quarterly events, suggesting that active camps can attract more potential new members. That is a great idea, and most of our camps participate in at least four events per year, although not all their own events, and that is something each camp should consider improving upon.

I would like to offer an additional thought that occurred to me while the four of us were riding in the parade. Why not designate four significant events within the state that have high public visibility, and have an "all hands on deck" roll out of members? We can decide which events are the most prominent throughout the state and endeavor to have a maximum turnout for these events. The last part of that sentence is a mouthful! I can hear you all now, "how can we get people out for these events in any significant numbers?" I think it

crossed over the river to rest under the shade of the trees on January 26 in Loudon, Tennessee.

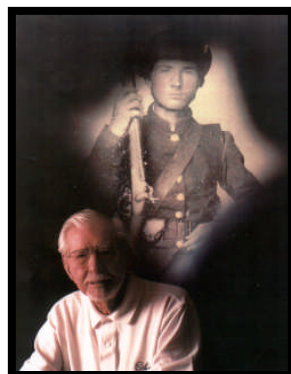

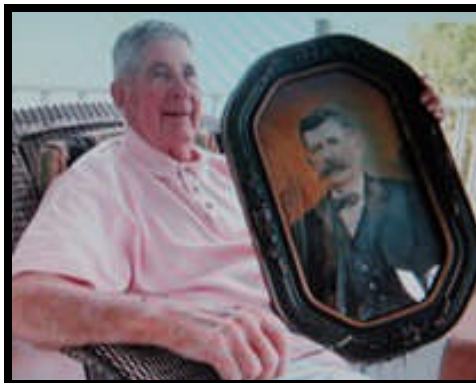
Lucas L. Meredith, Jr.  
1924-2012

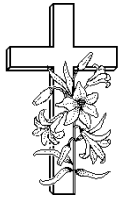
crossed over the river to rest under the shade of the trees on January 28 in DeWitt, Virginia.

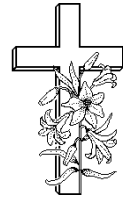

Marvin, four grandchildren and his brother, John.

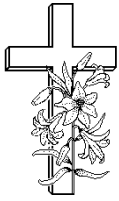
Joseph served in the U.S. Air Force and in the Ohio Army

A Masonic Memorial Service was held for Brother Potenza.

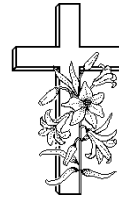

The Arizona Division had the privilege of an association with a "Real Daughter" and a "Real Son".

Mrs. Effie Turner, daughter of Pvt. Thomas Wood Machen, Co G, 31st Alabama Infantry, lived in Casa Grande. We became aware of her status as a "Real Daughter" through an article in *The Casa Grande Dispatch*.

The Division presented the SCV's Real Daughter medal to her at the Lee-Jackson celebration, 17 January 1998. At the same time, her son, COL(Ret) John Turner, was inducted into the ranks of Camp 1710.

In July, 1999, Bonnie Turner, a columnist at *The Arizona Daily Star*, wrote an article about James F. Brown, son of Pvt. James Henry Harrison Brown, Co K, 8th Georgia Infantry. Camp 1202 Commander Bobby Morris contacted Mr. Brown and recruited him as a member of the SCV.

The Arizona Division presented Compatriot Brown with his "Real Son" medal at a Camp 1202 meeting on 18 September 1999.

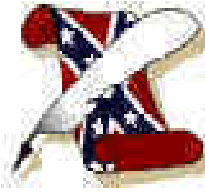

# Adjutant's Report

Compatriots,

This year is shaping up to be great one for our Division. Our Camps have taken part in several significant events related to the Sesquicentennial of the War for Southern Independence and for the Centennial of Arizona's Statehood. See the photos in the Camp News section. Our recruiting and retention efforts are going well. We have made up the losses of non-renewals and have several membership applications in process. The membership figures are posted below. Unfortunately, we have lost three members who have crossed over the river. We have an increase in membership of 8 since fiscal year 2011 ended.

Recruiting is going well. We have enlisted 16 new members, received 18 transfers—11 were internal to the Division—and processed 11 reactivations.

Two new Camps have been chartered—Yuma Territorial Outpost Camp 2186 in Yuma and Borderland Veterans Camp 2201 in Douglas. Efforts are underway to charter an-

other new Camp in the northeast portion of the territory.


The Division is in good financial shape. We do expect to expend approximately \$440.00 from the JROTC fund for this year's awards. We have received two applications as of 1 March 2012. Camp Commanders and Adjutants are reminded that funds are available to help defray expenses in graves preservation or sesquicentennial events. Requests should be submitted to me. The final decision on disbursement of funds rests with the Division Executive Council but that

is a simple matter to resolve. The decision can be made by electronic vote.

**Vision 2016—Membership Growth**

As mentioned, we have gained 16 new members and 7 transfers from outside our Division. We have, however, contacted nearly 100 prospective members and transferes. That's a recruiting rate of just 23%! We can do better! Successful recruiting depends on personal contact. Each of our prospects were contacted as soon as we learned of their interest. Let us now follow up on those gentlemen who have not yet responded. Contact them again! Each Camp should have a list of those men in their areas of operation. If needs be, contact me and I will provide you with those names and contact information! And while we are recruiting, let us not neglect retention. Keep your members active and interested! Remember the goal of Vision 2016—50,000 SCV members by 2016!

We will conduct a Vision 2016 workshop at the Division Convention to finalize our plans to implement this goal and to contribute to the Confederation's plans. Note that Vision 2016 does not just concentrate on recruiting. It encompasses several aspects of helping our SCV grow and gain prominence. We need to address Camp administration, retention, public affairs and all those aspects that make an organization a vital part of its community. This needs to be done at the Camp level—the Division officers and Executive Council members cannot do it! YOU, the SCV Com-patriot, are the key! As General Forrest said, "Charge 'em both ways!"

# Stereotypes--South & North

We quote William S. McFeely's Pulitzer Prize winning biography: *Grant: A Biography*

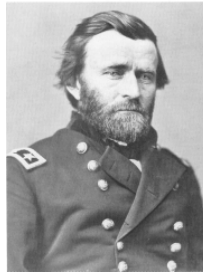
*In 1858 he [Grant] hired two slaves from their owners and borrowed one, William Jones, from his father-in-law. Jones, whom he subsequently bought, was about thirty-five years old and five feet seven inches tall, resembling Grant in both age and build, and they worked closely together.*

Not surprisingly, when readers learn of this for the first time, their reactions can range from indignant disbelief and ad hominum attacks on the message bearer to a grinning, head-nodding "I told you so." Yet both responses betray their own anchored stereotypes.

The true student of the past recognizes that every generation tends to interpret history in the light of their own experiences. Indeed, learning from the lessons of the past ... bettering our lives by avoiding the errors of our predecessors ... and passing along that acquired wisdom to our children is what advances civilization. Yet know that belief and bias share a number of common borders, often blurring those boundaries when convenience, motive, or personal gain influence our judgment.

For those who would vilify the 18th President, consider, as Paul Harvey would say, the rest of the story:

*On one occasion Grant was reported to have stopped the whipping of a slave by a farmer neighbor, and in 1859, when he was leaving the farm to go into*



*business in St. Louis and was severely pressed financially, he did not sell William Jones but instead set him free. Our comfortable stereotypes are indeed, subject to ambush.*

And yes, a number of you will remember that VMI Professor Thomas J. Jackson of Lexington, Virginia, organized a Sunday school class for blacks, teaching them to read the Bible and write their names in a society that often did more than frown on those who sought to make slaves literate. Fewer readers know that Sgt. Richard Kirkland, a South Carolinian, is the only enlisted soldier, North or South, who has a statue to his battlefield heroics in the South ... and the North.

Of course after you read this, some of you will remind the rest that Grant's opponent, Robert E. Lee, had likewise fulfilled the manumission clause in his father-in-law's will freeing the slaves at Arlington House, days after his stunning victory at Fredericksburg in December of 1862.

It's all out there waiting to be discovered. We just have to get beyond our biases ... our expectations ... and those stereotypes. And we can start with this one: beyond defeat, subjugation, and poverty, the South was left

with something else after Appomattox. You see, even today, many Americans perceive racism as a purely Southern problem. Back then, the fact that most blacks lived in the South gave the charge a measure of credence. Yet why blacks remained in the old Confederate states afterwards is a fact often, if not conveniently, overlooked.

To be sure, after the war, blacks did migrate to that "promised land of opportunity" only to find that the North offered no forty acres and a mule, or anything else beyond a legal declaration of freedom. The long range effects exploded decades later as race riots in Chicago, Tulsa, Detroit, Los Angeles, Philadelphia, Harlem, Boston and a dozen other metropolitan areas, graphically debunking this long held stereotype because racism in America has no sectional boundaries; it is a nationwide sickness.

Yet, as Jackson biographer James I. Robertson notes, "...it is the South that has remained the target for accusations of racial injustice. One might say, with unconcealed cynicism, that the South has had to bear the brunt of a national guilty conscience...far after the fighting stopped."

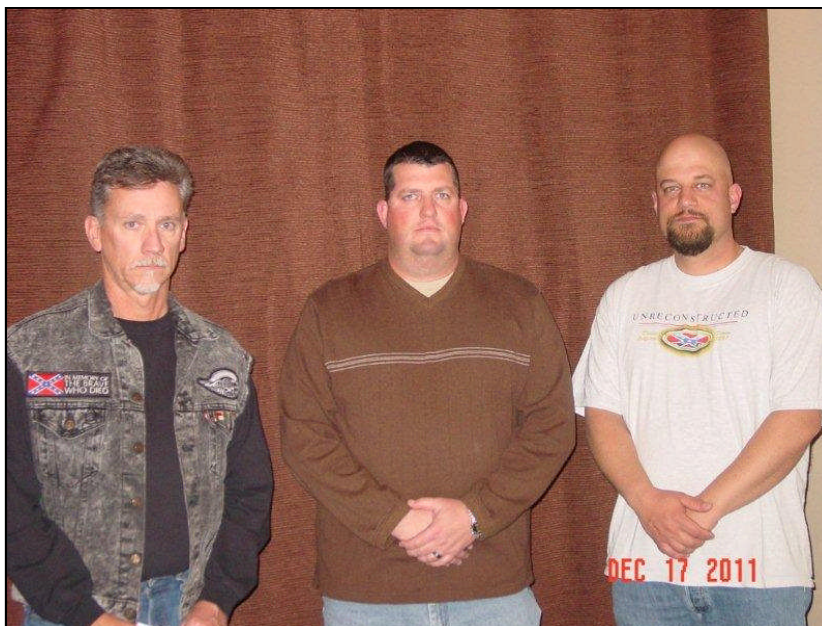
## **Camp 2186 Welcomes New Members!**

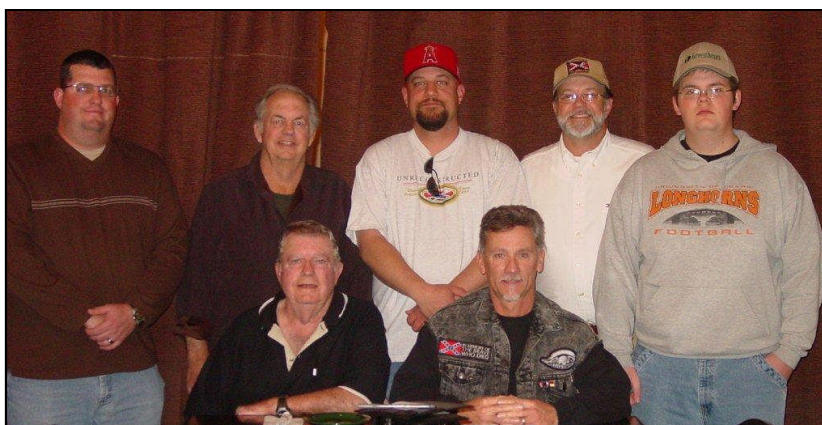
## **Camp 1710 Gives Living History Presentation!**

## **New Mexico Division Dedicates Confederate Memorial Cemetery in Socorro!**

The New Mexico Division of the SCV dedicated a memorial cemetery and a monument to Sibley's Brigade in Socorro on 24 February 2012. This is the first phase of a project to honor those Confederate soldiers who fell in battle or died of wounds at the Battle of Valverde, 22 February 1862. The remains of 27 Confederate soldiers will be reinterred at the site. Arizona Division Adjutant Curt Tipton attended the event.

A lone "protester" appeared just before the ceremony began, wearing a placard that stated, "No honor for those who fought to perpetuate slavery." NM Division Commander Jim Red invited the man, Dr. Richard Epstein, to take a seat during the ceremony and offered to let him resume his protest after the dedication. Dr. Epstein refused. The Socorro Police were called and an officer escorted the protester from the private property. The ceremony continued without fur-

## Arizona Division Recreates Sherod Hunter's Arrival in Tucson!

Members of Camps 1202, 1708, 1710 and 2074 represented the Arizona Division at a reenactment of the arrival of Confederate troops in Tucson, the occupation of the presidio and the raising of the Stars & Bars over the city. The actual event took place 150 years ago on March 3rd, 1862.

SCV members playing the role of members of Company A, Arizona Rangers, marched into the presidio. Captain Sherod Hunter, played by Division Adjutant Curt Tipton, greeted the “citizens” of Tucson (there were approximately 20 spectators in that role) and told them that Confederate troops had arrived to enforce the laws and protect the citizens from depredations by Apache warriors and Mexican and Anglo bandits. He read the proclamation, issued by Lt. Colonel John R. Baylor on 1 August 1861, establishing the military government of the Territory of Arizona and setting up courts, law enforcement and other government functions.

The Company A 1st Sergeant, played by Gadsden Brigade Commander Glenn Meek, lowered the US flag from the pole. He was assisted

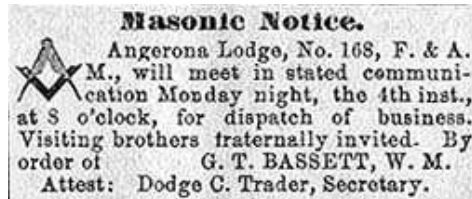

# Brotherhood at War



Nathan B. Forrest (1821-1877) Lieutenant General of the Confederate Army. Born July 13, 1821 in Bedford County, Tennessee. He first farmed in Hernando, Mississippi but moved to Memphis, Tennessee in 1852, and became a real estate dealer and broker in slaves. Entering the war in 1861 as a lieutenant colonel of cavalry, he distinguished himself with daring cavalry raids and was promoted to Brigadier General after the attack on Murfreesboro in 1862. Following the battle at Chickamauga, he was transferred to northern Mississippi and made a Major General. His harassment of the Union forces by cavalry raids and his capture of Fort Pillow in April, 1864 lead to his promotion to Lieutenant General in February, 1865. His actions at Fort Pillow, when he moved his troops to a commanding position under a flag of truce and then gave no quarter to the Negro troops, was questioned but refuted. His own report stated: *We busted the port at niner'clock and scattered the Yankees. The men is still a cillanem Yankees in the woods.* He was an Entered Apprentice in Angerona Lodge No. 168 at Memphis, Tennessee on October. 29, 1877. His Fellow Craft and Master Mason degrees were conferred later that year.

His great-grandson, Nathan Bedford Forrest III, graduated from West Point in 1928 and was commissioned a Second Lieutenant in the cavalry. In 1929 he transferred to the Air Corps and subsequently gained rank rapidly. He received his Masonic degrees in George W. Lininger Lodge No. 268 at Omaha, Nebraska. Promoted to Brigadier General in 1942, Forrest was serving as chief of staff of the Second Air Force when he flew missions as an observer with the Eighth Air Force in England. He was reported missing in action when the B-17 he was in, leading a bombing raid on the German submarine yards at Kiel, went down on June 13, 1943. The other members of the squadron reported seeing parachutes, and hoped that the General had survived. However, Forrest was found dead on September 23, 1943 when his body washed up near a seaplane base at Ruegen Island in Germany.
